

## Data Subject Consent for the Collection and Processing of Personal Data from the European Union

- 1) Pursuant to the European Union General Data Protection Regulation (“EU GDPR”), Louisiana State University (LSU), in its capacity as a data controller under the EU GDPR, LSU is seeking consent from you (the “Data Subject”) to collect and use your personal data, including sensitive data, for a lawful basis, which may include, but not limited to, employment, admission and enrollment, study abroad, internship abroad, online education, etc. For information on how LSU uses data, please review LSU’s privacy notices available here:

- 2) “Personal data” means any information relating to an identified or identifiable natural person (a “data subject”). An identifiable natural person is one who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location data, an online identifier or to one or more factors specific to the physical, physiological, genetic, mental, economic, cultural, or social identity of that natural person.
- 3) Any personal data that is collected from you in or transferred from the EU will be used solely for the following purposes:

and is necessary for that purpose. This may include processing the personal data as required to execute contractual obligations in connection with the previously described purpose and compliance with applicable laws, or to execute the obligations to you concerning your:
- 4) Personal data will be handled and processed only by the persons who are responsible for the necessary activities for the designated purpose(s), and will be transmitted from the EU to Louisiana State University, located at Baton Rouge, LA 70803.
- 5) Your personal data will be stored in accordance with the record retention requirements applicable to LSU as a public institution of higher education in the state of Louisiana, and any other applicable U.S.A. laws. Under the EU GDPR, the Data Subject has the right to request access to, rectify, erase and restrict the processing of your personal data. You also have the right to revoke this consent to use your personal data by contacting the Privacy Officer at [privacy@lsu.edu](mailto:privacy@lsu.edu). - 6) Refusal of consent may make it impossible for LSU to carry out its necessary activities for the designated purpose(s), and may preclude LSU’s ability to provide requested opportunities for employment to you. Further, regardless of whether LSU obtains your consent under this notice LSU is not precluded from processing your personal data for other lawful bases not requiring consent.
